

# **Conservative Kidney Management**

# **Project Update**

The Kidney Health Strategic Clinical Network is developing a provincial clinical pathway that will provide high-quality, evidence-based care for conservatively managed patients who are unlikely to benefit from dialysis.

Over the past few months, the project team has been drafting the clinical guidelines and engaging with stakeholders around the province. To understand the current challenges and opportunities related to conservative kidney care, we hosted two World Café Workshops engaging over 60 multidisciplinary providers, patients and families across the province and care settings (eg: outpatient, family practice, home care, long term care, inpatient, spiritual care,...).

These workshops generated tremendous feedback that is being used to guide the development of the CKM pathway, education plan, and implementation strategy.

### What is CKM?

Conservative Kidney Management (CKM) is a treatment option that some end-stage renal patients choose as an alternative to dialysis or transplant.

For some elderly patients, dialysis provides no benefit. These patients are often frail, and experience functional decline and cognitive impairment after starting dialysis. The last days of their lives are often characterized by high rates of hospitalization, ICU admissions, and intensive procedures.

Patients whose chronic kidney disease is managed conservatively (without dialysis) may live as long as patients who elect to start dialysis. They tend to preserve their functional status, maintain a better overall quality of life, and have fewer hospital admissions.
